The three broad Sub themes, under the main theme of “Governance and Policy Reforms: An Indo-Pacific Perspective” are as follows:

- **Day 1:** Welfare State Policy and Governance
- **Day 2:** Sectoral Policy Reforms – Status and Evaluation (Health, Education, Economic and others)
- **Day 3:** Environmental Governance and Policies for Achieving Sustainable Development Goals.

## Submission Guidelines (Abstract)

1. Co-authorship is limited to a maximum of two authors.
2. Submission of one paper presentation proposal only by a participant
3. The abstract shall not exceed more than 300 words including keywords. The abstract must be accompanied by a Cover page which must include the following details:
  - Title of the Paper
  - Name of the Author and Co-author (if any)
  - Designation
  - Affiliation
  - Contact details of Author and Co-author
4. The Abstract shall be submitted with the google form of registration on or before 11<sup>th</sup> of June, 2021 in MS- Word file format(.doc/.docx) only.
5. The MS Word file must be named in the manner which is as follows:
  - Name of the Author and Co-author (if any) followed by the title of the work.

## Submission Guidelines (Full Paper)

1. The title of the manuscript shall be followed by Name of the author(s), the Name of the University/ Institution, and the E-mail address.
2. The manuscript should be submitted in MS-Word (.doc/.docx)format only.
3. For citation, APA style of citation shall be followed.



4. All manuscript submissions shall only be made in soft copies along with the duly signed certificate of originality as an attachment to the google form send on the mail of the authors, if selected, on or before the 5<sup>th</sup> of July 2021.
5. The MS-word file of the manuscript must be named in the prescribed manner as provided in the mail.
